Dear Ms. Arnold,

In response to your letter dated February 9, 2000, to the Honourable Paul Martin, Minister of Finance, I am writing to express my support to eliminate the "Right of Landing Fee" (ROLF). As a former immigrant from Poland, I am committed to fair and just immigration policies for all immigrants. I support the removal of economic barriers which causes undue delays in the landing of immigrants and refugees.

Canada, as a multicultural country, should have a policy allowing people to apply for immigrant status despite of their economic situation. Many future immigrants would be unable to land in Canada because of their poor economic status. Economic status should not be the main factor in allowing people to immigrate to Canada.

The economic factor is very difficult to eliminate when immigrants are fleeing personal persecution because of their political beliefs. A lot of abused women would be able to immigrate from their abusive partners and even save their lives if they did not have to pay to immigrate to Canada. A lot of new immigrants are not able to pay "Right of Landing Fee" to sponsor their close relatives (husbands, wives, children and parents) simply because they are still struggling not able to find better paying jobs because of the language barrier.

Please implement the removal of the "ROLF" charges and make Canada a place where people are able to apply to immigrate to despite of their race, gender, beliefs and economic situation.


