Please accept this letter as a request to look into the following serious matter of duplication of civic numbers along River Road, Osgoode Township extending into South Gower Township. Their is a duplication is civic numbers from 3560 to 3809 and covers an area of approximately four miles with no changes to the road's name. In general, numbers in Osgoode Township end at 3809 River Road, and South Gower Township start at 3560 River Road. This serious duplication of civic numbers may result in a delay in Emergency Services from arriving at the correct address, this delay could result in the life threatening illness/injuries in becoming fatal.

By receipt of this letter, I am requesting that the 9-1-1 Advisory Board solicit Osgoode or South Gower townships to changing civic number along River Road. I would also suggest that the 9-1-1 Advisory Board monitor this situation and report of any problems which may arise in the delivery of emergency services to the respective townships. Likewise, I would suggest that Osgoode and South Gower monitor any problem in the delivery of emergency services in their respective townships.
