SUBJECT/OBJET DISCONTINUATION OF SHARED PARENTING BENEFITS

This information is being provided to all Regional Councillors in the event that you receive calls from residents of your ward regarding this change.

For several years, the Social Services Department has had a progressive Shared Parenting policy, which provided a modest additional sum of money to separated and divorced parents receiving Social Assistance, who had shared parenting arrangements and who shared the cost of caring for their child(ren). This assistance was granted where a parent could demonstrate an on-going shared parenting arrangement. It reflected our commitment to addressing child poverty.

The proclamation of the Ontario Works Act on May 1st, 1998, introduced a new provision that only the primary custodial parent is eligible to receive social assistance benefits on behalf of a child. The "non-custodial" parent is to be treated as a single person.

By Provincial definition, the primary custodial parent is the one who receives, or is eligible to receive, the Federal Child Tax Credit/ National Child Benefit. This applies regardless of any formal/legal shared parenting or joint custody arrangements.

The Department has already introduced this new requirement for all new Ontario Works applicants. However, we are also unable to continue to grant additional financial support to existing non-custodial parent cases.

In recognition of the hardship that this change may cause, the Department has decided to provide clients with at least 90 days notice of the discontinuation of this assistance. Therefore, all existing cases receiving this assistance will be notified by the end of August, 1998, that the extra benefit will no longer be available as of December 1st, 1998.

Attached to this memo is a sample letter which will be provided to all recipients currently receiving the shared parenting benefits. The letters will sent by August 31, 1998.

The Department is treating this as a "touch the file" initiative, which is how MCSS describes those policy changes which came with the proclamation of the Ontario Works Act, but which need not be fully implemented before the end of 1998.

An analysis was completed of our expenditures for this benefit in December, 1997. In that month, there were 630 cases which received extra assistance for shared parenting, at an average cost of \$159 per case, for a total of \$100,260. Annualised, this is an expenditure of \$1,203,120.

SAMPLE LETTER TO CLIENTS

Dear

On May 1st, 1998, the Government of Ontario replaced the General Welfare Assistance Act

(GWA) with the Ontario Works Act (OWA). Effective that date, many rules have changed.

The new law prevents the Social Services Department from giving benefits for a child or children,

to anyone other than the primary care giver or custodial parent. This is the parent who receives,

or is eligible to receive, the Federal Child Tax Benefit.

You have been identified as one of the parents who has been receiving extra money.

Unfortunately, starting December 1st, 1998, your Ontario Works cheque will no longer include an

amount for shared parenting.

Should you have any questions about the amount of money you will get, you can call your

worker. If you have concerns about the new rules, you can contact your Provincial Member of

Parliament.
