## **BACKGROUND**

The *Corporate Policy Manual* requires the Treasurer to report annually to the Corporate Services and Economic Development Committee on the operations of all petty cash, change funds and imprest bank accounts established under Chapter 4, Annex 4-A.

Attached is a list of these funds held by each department (Annex A) at various locations in accordance with Corporate Policy. These funds provide on demand reimbursement to individuals purchasing goods and services for Regional business as well as a facility to provide change to the public when purchasing miscellaneous goods and services provided by the Region.

A review of the operations of all petty cash and change funds was made as at December 31, 1999. The review included the petty cash and change funds for OC Transpo. All custodians were contacted to verify and certify the amount of cash and paid vouchers on hand. The certificates were checked with our accounting records and found in order.

There are cash funds in the amount of \$123,315.00 held throughout the organization as outlined in Annex A. During 1999, five Regional petty cash funds required increases totalling \$1,180.00. During the year end review, Police Services reduced its petty cash requirements by \$3,350.00. The net result of these changes was a decrease in the amount of petty cash and change funds by \$2,170.00.

During 1999, OC Transpo increased its cash on hand by \$12,900.00, bringing the total amount of such funds to \$46,930.00.
