#### **DEPARTMENTAL RECOMMENDATION**

That the Corporate Services and Economic Development Committee and Council approve the extension of Tender 0885-38BB-T1/96 for the supply of Sodium Hypochlorite at the Robert O. Pickard Environmental Centre to Colgate-Palmolive Canada Inc., Toronto, for a total contract provision of \$143,237 for the period of 1 March, 1997 to 28 February, 1998.

#### **RATIONALE**

As a component of the wastewater treatment process, Sodium hypochlorite is used for disinfection of the final effluent discharged from the Robert O. Pickard Environmental Centre.

A tender for the supply of Sodium hypochlorite for the period of 1 March, 1996 to 28 February, 1997 was awarded to the lowest responsive bidder Colgate Palmolive Inc. in March 1996.

The tender was issued for the period 1 March, 1996 to 28 February, 1997 with a provision to extend the contract for two additional 12-month periods subject to satisfactory performance and acceptable terms and conditions. The unit price tendered was \$0.127 per litre.

The Supply Management Division contacted both Colgate Palmolive Inc and Lavo Co. Ltd. to evaluate the stability of Sodium hypochlorite pricing. Lavo Co. Ltd. indicated that due to increased manufacturing costs their price would increase from last years quote. Colgate Palmolive declined to extend current pricing for a two year period due to uncertainty in future chlorine prices. However, Colgate Palmolive has offered to extend the current pricing for a one year period.

The required quantity of Sodium hypochlorite for the Robert O. Pickard Environmental Centre is 1,054,066 litres, and the estimated cost will be \$133,866, plus an allowance of \$9,371 for G.S.T., bringing the total contract provision to \$143,237.

#### CONSULTATION

The public consultation process is not applicable.

#### **EXPENDITURE JUSTIFICATION**

The supply of the Sodium hypochlorite chemical is essential and required for Final Effluent disinfection. Disinfection of the Final Effluent is an integral part of the wastewater treatment process and is in accordance with the Ministry of the Environment and Energy's Certificate of Approval.
