## **COUNCIL MINUTES**

The Council of the Regional Municipality of Ottawa-Carleton met at Haydon Hall, Regional Headquarters, 111 Lisgar Street, Ottawa on Wednesday, 8 October 1997 at 1:30 p.m.

The meeting was called to order at 1:37 p.m. and opened in prayer.

The Acting Regional Chair, Betty Hill, presided.

## ALL MEMBERS WERE PRESENT EXCEPT CHAIR CLARK AND COUNCILLOR B. MCGARRY.

#### **CONFIRMATION OF MINUTES**

The minutes of the Regular Council meeting of 24 September 1997 were confirmed.

#### IN MEMORIUM

At the request of the Acting Chair, members of Council rose and observed a moment of silence in memory of Bradley Clark, son of Regional Chair Peter Clark, who passed away on 28 September 1997.

# DECLARATIONS OF INTEREST ARISING FROM PRIOR MEETINGS OF COUNCIL AND COMMITTEES

No declarations of interest were filed.

#### **COMMUNICATIONS**

- 1. Virginia Gaffney, Fund Development & Communication, Ottawa-Carleton Branch, Canadian Red Cross providing a letter to M. Beckstead expressing thanks for assisting the Manitoba Relief Fund. She advises that, thanks to organizations such as the RMOC, donations are currently over \$17 million.
- 2. Cyril Leeder, President, Corel Centre, providing a letter to the Chair discussing the enclosed correspondence to the National Hockey League. It states their regrets and inability to bid for 2000 and 2001 NHL All star Weekend due to lack of a facility in the region with a minimum 200,000 sq. ft. of space and strongly urges Council to move forward on construction of a convention centre of this size.
- 3. Ministry of Municipal Affairs and Housing responding to the Chair's letter regarding the financial implication of the Who Does What Transfers.
- 4. A memorandum to Council from the (CCAC) Community Care Access Centre, Members of CUPE, Local 503 wishing Council to intercede on their behalf against Bill 136. They enclose a petition with 55 signatures.
- 5. Two news releases from (AMO) Association of Municipalities of Ontario entitled, *Government Retreats on Bill 136*, outlining The Honourable Elizabeth Witmer, Minister of Labour's statements regarding the amendments to Bill 136. AMO does not agree with the government's position and will communicate its displeasure to the government with respect to these amendments to Bill 136.
- 6. Township of Goulbourn providing a copy of a resolution adopted by Goulbourn Council at their 2 September, 1997, that no question on local governance be placed on the ballot in November without concurrence of all other area municipalities and the RMOC.
- 7. Township of Goulbourn providing a copy of a resolution adopted by Goulbourn Council at their 2 September, 1997, meeting regarding public transportation in Goulbourn. Their resolution requests the RMOC to extend subsidy to the Goulbourn Transportation system, in proportion to the amount received in property taxes.
- 8. Township of Goulbourn providing a copy of a resolution adopted by Goulbourn Council at their 2 September, 1997 meeting regarding long distance charges in the Regional Municipality and calling upon the RMOC and OCEDCO to lobby Bell Canada and the CRTC on this matter.
- 9. Rhéal Leroux of the Bid Submission Committee of the Jeux de la Francophonie 2001, extending their thanks and appreciation to the RMOC for their cooperation and financial assistance for the successful bid to host the 2001 games.

- 10. Clerk, City of Gloucester, transmitting a petition on behalf of the "Preserve the Greenbelt" committee. The petition voices the opposition of community residents to the sale of Greenbelt lands located in Blackburn Hamlet.
- 11. The Honourable Marilyn Mushinski, Minister of Citizenship, Culture and Recreation, responding to Council's resolution concerning proposed amendments to the Human Rights Code, outlined in Bill 96, the Tenant Protection Act.

- 12. The Honourable Al Leach, Minister of Municipal Affairs and Housing, providing and update on information relative to "Who Does What." He advises that meetings with Ministry staff will begin on 6 October, to review the numbers with the various ministries.
- 13. Ministry of Municipal Affairs News Release entitled *Regulation Clarifies Municipal User Fees*. Among the fees discussed, the Ministry is refusing to allow lower tier municipalities to charge upper tier and school boards for the cost of running municipal elections.
- 14. Georges C. Clermont, President of Canada Post Corporation, providing an update on negotiations with CUPW, as they work toward averting a mail strike.

#### **COMMITTEE RECOMMENDATIONS AS AMENDED**

- 1. The installation of traffic control signals at Nortel's proposed southerly site access and Moodie Drive (Regional Road 59) and the construction of the associated roadway modifications along Moodie Drive, and modifications to the intersection of Carling Avenue (Regional Road 38) and Grandview Road as discussed further in the report's Design Proposal Section and as illustrated in Annex D, subject to a public hearing if required and subject to the owner, Northern Telecom Limited;
  - a. funding the total cost of the proposed road works which would include paying the annual maintenance costs for the traffic control signals until such time as they meet the Ministry of Transportation of Ontario installation warrants and Council approves the assumption of the costs;
  - b. executing a legal agreement with respect to the above;

- 2. That the comments of the Regional Cycling Advisory Group be incorporated in the final report and that cyclist safety at the intersections of the Moodie Drive and Carling Avenue accesses and crossing the Queensway also be commented upon in the final report.
- 3. That the Regional site plan agreement include a plan for the decommissioning of parking spaces resulting in a final total of 4200 parking spaces.
- <u>4.</u> That the annual transportation demand management report be brought to the Transportation Committee.
- 5. That a report on the Queensway ramps at Moodie Drive be available prior to the Public Hearing on 19 November 1997.

5. PROPOSED MEDIAN EXTENSION ON HAZELDEAN ROAD (REGIONAL ROAD 36) 64 M EAST OF EDGEWATER DRIVE

#### **COMMITTEE RECOMMENDATION**

That Council approve the 25.5 metre easterly extension of the existing median immediately east of Edgewater Drive as illustrated in Annex B, subject to the owner, TDL Group Ltd.:

- a. funding the total cost of the proposed road works, and;
- b. executing a legal agreement with respect to (a) above.

- b. the Township of Cumberland being responsible for the annual maintenance and operating costs, and;
- c. executing a legal agreement with respect to a. and b.

7. TRAFFIC CONTROL SIGNALS - RICHMOND ROAD (REGIONAL ROAD 59) AND SEYTON DRIVE

#### **COMMITTEE RECOMMENDATION**

That Council approve the installation of a traffic control signal on Richmond Road (Regional Road 59) and Seyton Drive, subject to:

- a. the City of Nepean paying all costs associated with the installation of this signal;
- b. the City of Nepean being responsible for the annual maintenance and operating costs;
- c. the City of Nepean paying all costs for the design and construction of a northbound left turn lane at Richmond Road (Regional Road 59) and Seyton Drive should the City of Nepean or the RMOC at the request of the City implement any measure to restrict the northbound through movement on Moodie Drive between West Hunt Club Road (Regional Road 32) and Richmond Road (Regional Road 59), and;
- d. executing a legal agreement with respect to a., b. and c.

8. ROAD CLOSING - PART OF HUNT CLUB ROAD AT THE CORNER OF BANK STREET - CITY OF OTTAWA

#### **COMMITTEE RECOMMENDATIONS**

That Council approve:

1. A By-law to close those parts of Hunt Club Road at the corner of Bank Street described as Parts 1 and 9 on Plan 5R-14483 and Block E on Plan 4M-235;

2. That staff proceed with the sale of those Parts as directed by Council.

9. KENT STREET AT LISGAR STREET - WESTBOUND THROUGH PROHIBITION
