- 2. the award of Contract CW 8617 Office Fit up to Pranger-Debruyn Construction Limited, Nepean, Ontario for a total contract provision of \$60,615.50.

BACKGROUND

The 951 Clyde Avenue facility was constructed in 1984 to serve the needs of the operation and maintenance of the Water Distribution System. The facility is currently used to house not only the Water Distribution activities but also accommodates various support groups from the Engineering Division, Finance Land Administration Division and Corporate Fleet Services.

The Water Division Operations facility currently does not conform to the Ontario Building Code in providing barrier free access to both floors of the structure. To extend barrier free access to the second floor of the facility an examination of options was conducted including the cost of installing an elevating device. The recommended course of action from this study was the installation of a standard elevator (2500 lb. capacity) capable of serving general vertical transport needs, as well as those of the disabled.

Furthermore, changes since 1986, including operating practices, organizational structure, computerization and service provision have also created inefficiencies in the use of existing facility space. Over the years changes in space usage has resulted in air quality problems as ventilation systems designed for a particular function or area are now improper for the current requirements.

The two contracts being recommended provide for the modification of the Clyde Avenue Water Division facility by installing an elevator to provide barrier free access to the second floor of the building and modifying the existing space to better accommodate the requirements of the Water Distribution System workers and visitors. An additional component of the work will be to modify the existing HVAC system to address air quality concerns at the facility.

The office fit up will more efficiently utilize existing space and address air quality concerns.
