BACKGROUND

As part of the corporate Geographically Referenced Information System (GRIS), the Automated Mapping/Computer Aided Design and Drafting (AM/CADD) requirements of the Corporation are met by the hardware and software products provided by Intergraph Canada Limited. This contract award is an extension of an existing agreement with Intergraph Canada which will allow for the continuing maintenance of the equipment that the Corporation has purchased. While this contract will cover the period until April 2000, the Corporation has the option of cancelling this agreement at any time with one month's notification. The cost of this contract is based upon a monthly charge for the equipment that the Corporation currently has and charges will be adjusted in the event that the equipment under service agreement changes at any time during the term of the agreement.

The cost of this maintenance will be recovered, over time, from the Capital projects for which the equipment is used.

EXPENDITURE JUSTIFICATION

It is necessary to keep this equipment under maintenance in order to ensure staff have the required hardware and software tools to address their business activities. Intergraph is the supplier of the original equipment and as such are well qualified to provide the maintenance activities. As the majority of the maintenance costs are associated with proprietary software products Intergraph is the only supplier of the software maintenance.
