Dear Minister Witmer,

As we assume you are aware, federal pesticide registration policy has in the past focused on the effectiveness of pesticides and their use in agriculture and forestry. It has proven sadly inadequate to protect the health of Ontarians not in perfect health from incidental exposure to pesticides in crowded urban areas.

Although there are registered non-volatile attractant baits for cockroaches, the federal government still permits the spraying of entire apartments with diazinon, chlorpyrifos and xylene. There are municipal staff trained in forestry who consider it acceptable to spray the entire length of a residential street up to 20 meters in the air with nerve poisons because there might be aphids there, and the federal government still permits this to occur.

Your colleague, the Hon. Al Leach has drafted a new Municipal Act to provide, among other things, that Ontario municipalities may restrict pesticide use in urban areas for reasons of public health. However, the Pesticides Act, administered by the Ministry of the Environment, still prohibits all pesticide regulation other than what is provided by itself.

The **Health Dangers of Urban Use of Pesticides Working Group** of the Regional Municipality of Ottawa-Carleton therefore asks that you prevail on your colleague, the Minister of the Environment, to provide for an amendment to the Pesticides Act to permit municipalities to opt for a local preference option. This would allow for pesticide application in Ontario to be further restricted by municipalities for health reasons, or by Medical Officers of Health under the Health Protection and Promotion Act.

Dear Minister Leach,

We support the request of the Council of the Regional Municipality of Ottawa-Carleton that they be empowered to restrict pesticide use in their urban areas more than is appropriate in agricultural or forestry areas, for reasons of public health. As such, we have received a copy of your letter to the Regional Clerk informing her that you expect that the new Municipal Act will allow the RMOC to do that.

We welcome a clarification of the Municipal Act in this area, and trust that you will also make a matching provision in the Regional Municipalities Act. As Canadian courts have already ruled that powers equivalent to those in Ontario's present Municipal Act permit such municipal action in general, the problem in Ontario is not the Municipal Act, but the Pesticide Act.

The **Health Dangers of Urban Use of Pesticides Working Group** of the Regional Municipality of Ottawa-Carleton therefore asks that you prevail on your colleague, the Minister of the Environment, to provide for an amendment to the Pesticides Act to permit municipalities to opt for a local preference option.

Minister Sterling,

As we trust you are aware, your colleague the Hon. Al Leach plans to introduce a new Municipal Act to specifically provide, among other things, that Ontario municipalities be empowered to restrict pesticide use in their urban areas more than is appropriate in agricultural or forestry areas, for reasons of public health. We welcome his clarification of the Municipal Act in this area. But, Canadian courts have already ruled that the powers equivalent to section 120 of Ontario's Municipal Act permit such municipal actions in general. The problem in Ontario is not the Municipal Act, but the Pesticides Act, for which you are responsible.

The federal registration system inadequately protects the health of Ontarians not in perfect health from incidental exposure to pesticides in crowded urban areas. Although there are registered non-volatile attractant baits for cockroaches, the federal government still permits the spraying of entire apartments with diazinon, chlorpyrifos and xylene. There have been incidences of municipal staff trained in forestry who consider it acceptable to spray the entire length of a residential street up to 20 meters in the air with nerve poisons because there might be aphids there. The laxity of the present legislation permits and possibly encourages the use of potentially very harmful chemicals.

The **Health Dangers of Urban Use of Pesticides Working Group** of the Regional Municipality of Ottawa-Carleton therefore asks that you provide an amendment to the Pesticides Act to permit municipalities to opt for a local preference option, allowing for pesticide application in Ontario to be further controlled by municipalities for health reasons.
