BACKGROUND

Since 1993, Regional Council through the Health Department has contracted with the Ontario Ministry of Health to operate the Program Training and Consultation Centre of the Ontario Tobacco Strategy in partnership with the University of Waterloo, Centre for Applied Health Research and RBJ Health Management Associates. The Centre has a mandate to provide training and consultation in tobacco use prevention to communities across Ontario. A six month workplan and budget of \$150,000 for the operation of the Centre has been approved by the Ministry for the period October 1, 1998 - March 31, 1999 (see Annex A) as an extension of the existing contract between the Ministry of Health and the Region of Ottawa-Carleton.

Key roles of RBJ Health Management Associates include:

- design and delivery of training workshops and provide on-site/off-site consultation services;
- development of specific program resources;
- conduct planning and evaluation for the centre;
- advise PTCC Management Committee and other committees as appropriate.

Details are specified in the approved workplan.

Key roles of CAHR include:

- review and update ACTION Programs Guide;
- develop materials to support PTCC training workshops;
- conduct on-site consultations as requested;
- advise PTCC Management Committee, Coalition of Ontario Agencies for School Health and other committees as appropriate;

Details are specified in the approved workplan.

PUBLIC CONSULTATION

The PTCC has three key user groups: Ontario public health units, local Councils on Smoking and Health across Ontario, and Ontario community health centres. Ongoing evaluation is conducted for all activities. All services provided for PTCC by these contractors have been evaluated by users and other participants as very good to excellent.

FINANCIAL IMPLICATIONS

This is a 100% Ministry of Health funded program. Funds will be provided for in 792-55721.
