OAPSB Calls on Provincial Government to Take Long, Hard Look at OPP Costs

This week, OAPSB released a statement to the media in response to comments made by Premier Dalton McGuinty:

This morning, Premier McGuinty said that municipalities should look at banking of sick days for police and firefighters in their municipal services to control costs. We agree with the Premier's comments that municipal forces need to curb costs; however, the Ontario Association of Police Service Boards further calls on the provincial government to take responsibility for the costs of its own police - the OPP. OPP contracts are negotiated directly between the provincial government and the OPPA, and those contract talks are happening right now.

While the OPP do not bank sick days, there are opportunities for savings and the OAPSB calls on the government to take a consistent approach to OPP contract negotiations (as they have with other public sector workers) to curb the unsustainable and exponentially rising costs of policing. Not only do OPP contracts impact the municipalities that use OPP services, but they also set the example for other police service contracts, driving costs up across the province.

Template Letter for OAPSB Members

Dear [Name],

Our police forces do important work keeping our communities safe. But our municipalities and our province are facing serious financial challenges, and we need to make sure that we are spending taxpayer dollars effectively and efficiently. It's the only way to keep our communities safe and prosperous, in the long-term.

If we are going to get serious about fiscal responsibility, we also have to look at policing. And we have to look at the single largest police force in our province, the OPP. With costs continuing to rise unchecked, we believe there are opportunities to curb costs and stop the pattern of exponentially rising costs - if the province commits to tackling the problem.

Unfortunately, boards that use and pay for OPP contract services have no input into the negotiation process. The impact is broad, as even non-OPP municipalities and taxpayers are forced to meet OPP contract terms for their own forces.

The government has said: there is no new money for pay. I/we call on you and your party to work to ensure fiscal responsibility across all sectors of the broader public service, including the OPP.
