- 1. THAT the Council of the City of Kanata approve an amendment to the 2000 Capital Budget for the Kanata Senior Centre from the previously approved budget of \$981,173.00 to \$1,048,914.00.
- 2. THAT the Council of the City of Kanata approve additional funding for the Kanata Senior Centre in the amount of \$67,741.00 to be funded from the Development Charges Reserve Fund \$51,370.00 and Kanata Capital Reserve \$16,371.00.

- 3. THAT the Council of the City of Kanata approve the following modifications to the project scope and budget for the Senior Centre which amounts to cost reductions of \$71, 366.00 as follows:
  - a) Deletion of retrofit work for washrooms and ancillary features associated to the John G. Mlacak Community Centre to a total of \$33,446.71.
  - b) Reduction of the furnishings and fittings budget from \$100,000.00 to \$75,000.00 resulting in a savings of \$25,000.00.
  - c) Reduction of the project contingency fund from \$76,465.00 to \$60,000.00 resulting in a savings of \$16,465.00.
  - d) GST Rebate adjustment (\$3,546.00).
- 4. THAT the City of Kanata approve the tender of Dolyn Construction of \$843,796.00 for the construction of the Kanata Senior Centre project.
